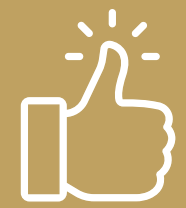

## 4 | Company Formation with an e-Resident Card







The e-Residency card is issued by the Estonian government to non-citizens of Estonia. It gives access to e-services of Estonia and the European Union i.e. it allows you to register a company in Estonia remotely (without visiting Estonia). To set up a company in Estonia, you are required to have the e-Resident card, a legal address and a contact person in Estonia.

## 5 | Company Registration by Visit in Estonia






## 6 | Company Formation by Power of Attorney










To open a company in Estonia by power of attorney, you must comply with all the terms of cooperation and pay for the services before starting the process. After obtaining the powers of attorney, the process of establishing a company takes about **two weeks**.

### SEQUENCE

- 1 **Company in Estonia OÜ** will send an example of power of attorney in English based on the documents and information received from the client.
- 2 Based on the legislation of your country, it is necessary to prepare a sworn translation of the power of attorney into the state language.
- 3 After sworn translations of all powers of attorney into the state language, it will be necessary to certify all powers of attorney at a notary and apostille them.
- 4 After the powers of attorney have been drawn up, they will need to be translated into English by a sworn translator.
- 5 After certification and translation of all powers of attorney, they will need to be sent by courier to **Company in Estonia OÜ** at Sepise 1, Tallinn, 11415, Estonia.

## 7 | Ready-Made/Shelf Companies in Estonia



